What are the needs and Obstacles of our Students and how can we change them	<ul> <li>Child care-to better serve our students we would like to see:</li> <li>Provide evening and weekend childcare</li> <li>Summer camp to be offered to older children during summer classes</li> <li>Vouchers given to students (similar to Cal works program), will pay for offsite provider if licensed and approved</li> <li>Check with Children's Home Society and Parks and Recreation</li> <li>College daycare will take as young as 5 months</li> <li>CEC and OEC daycare will take- 2.9months-preschool –Kdg-readiness</li> </ul>

	reading level and is now on the computer only, compared to a 6 <sup>th</sup> -8 <sup>th</sup> grade level that our students are used to-big gap
	Our students aren't prepared for these changes-they are lacking in reading, computer, language and science skills
	<ul> <li>The closest testing site is Irvine Valley, our district is in the process of opening a testing site</li> </ul>
	<ul> <li>Walk in center with computers would be needed to practice skills</li> <li>Offer a pre-GED class to cover the skills they are lacking before they enter the GED classes</li> </ul>

• Old version of GED was 80% fiction –new version is 80% non-fiction,	
this and critical thinking skills are higher level-students not prepared	
• Lori discussed adding support classes as a package-math and reading	
as learning community classes	
Julia discussed adding a counseling course to go along with GED, also	
in Spanish	
• Sue discussed gaps when student comes to us for HSS classes-to help	
maintain skills they learned-we can add refresher classes
